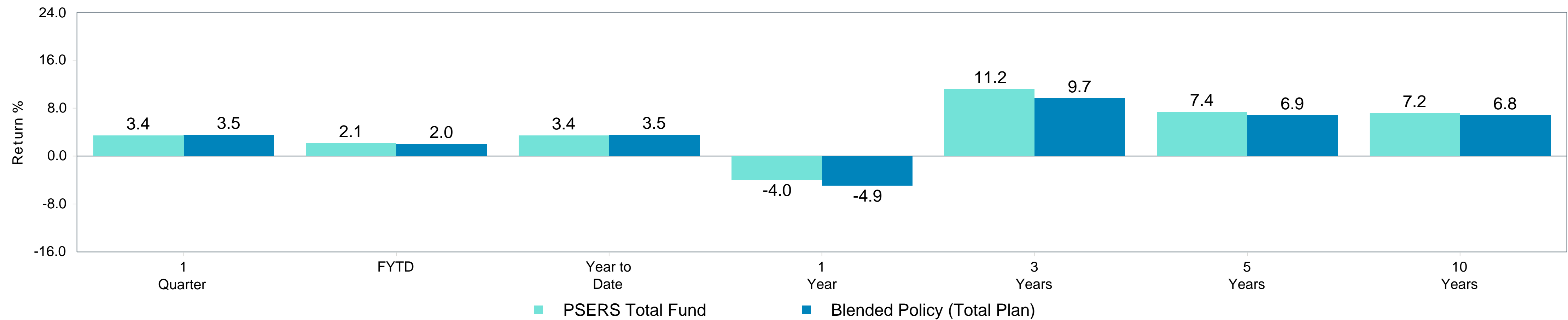

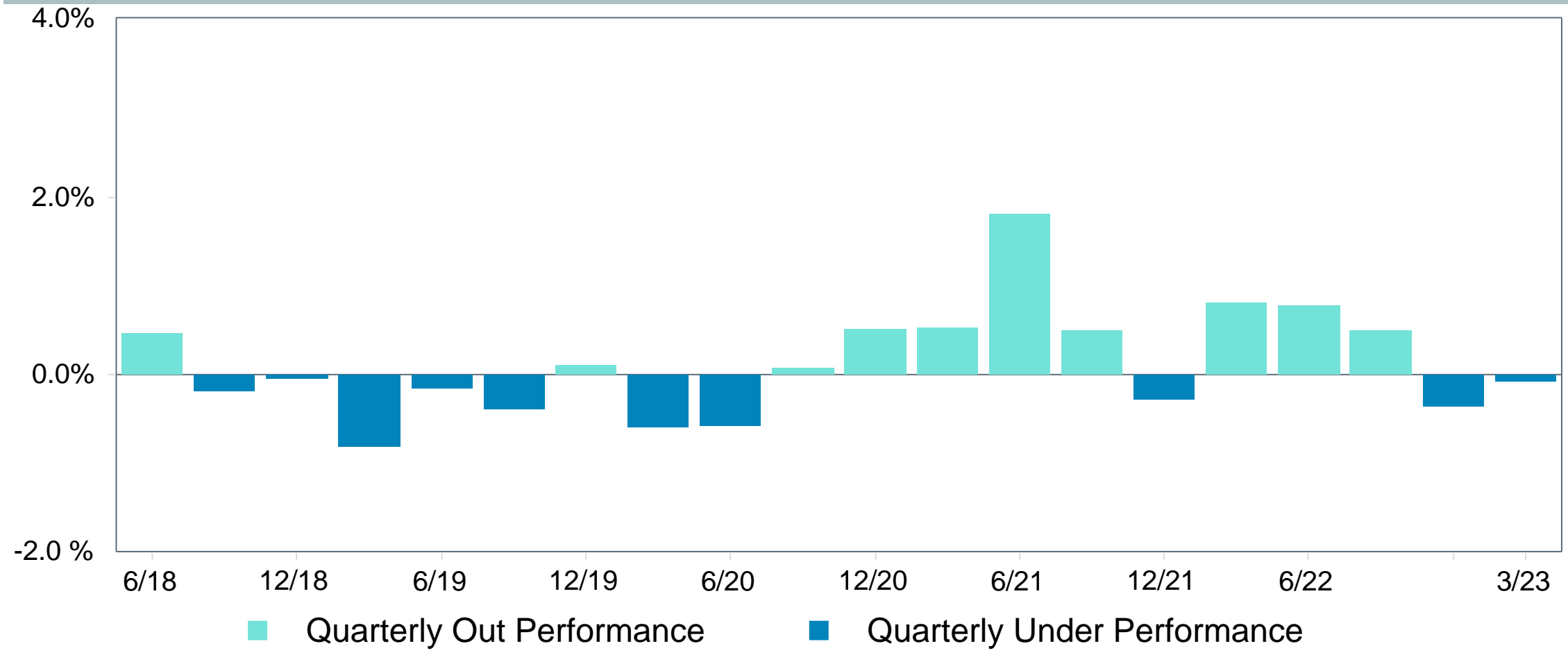

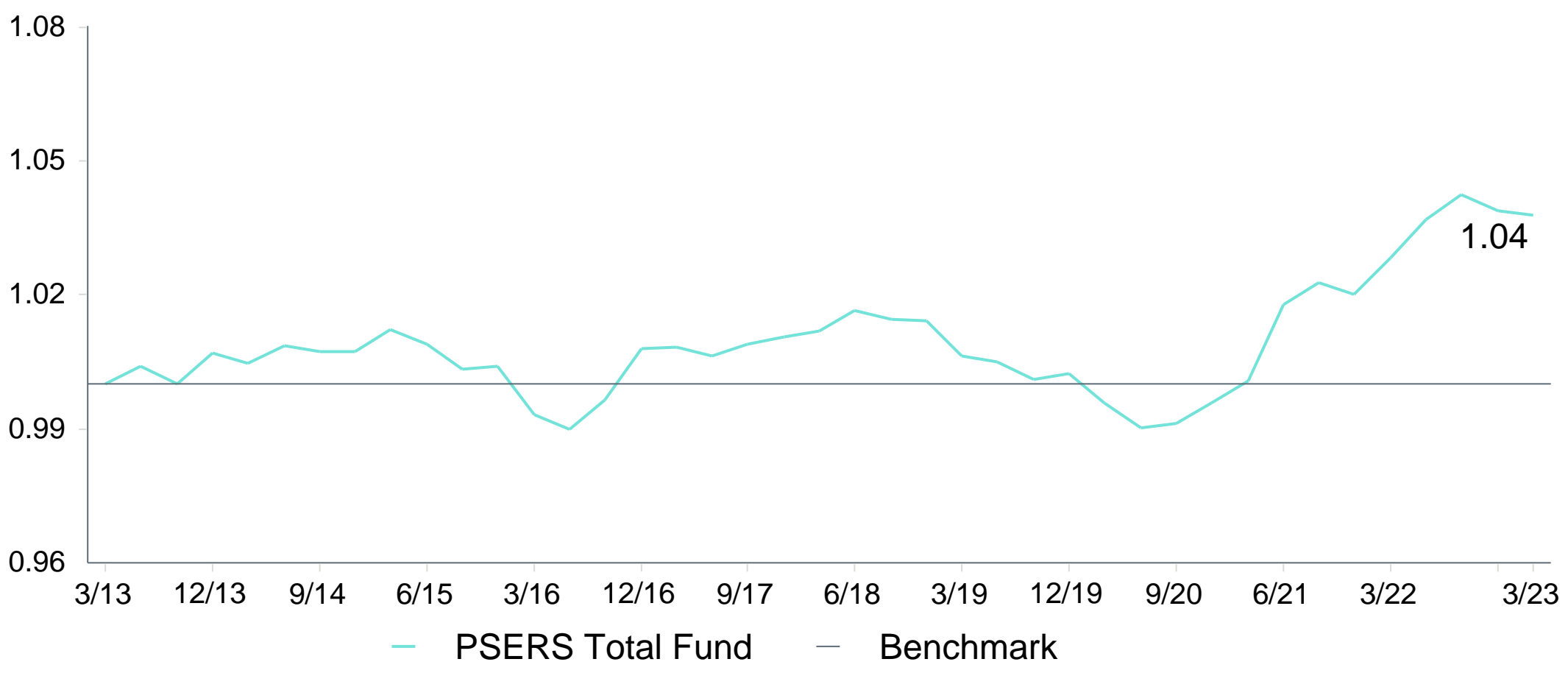
### Return Summary

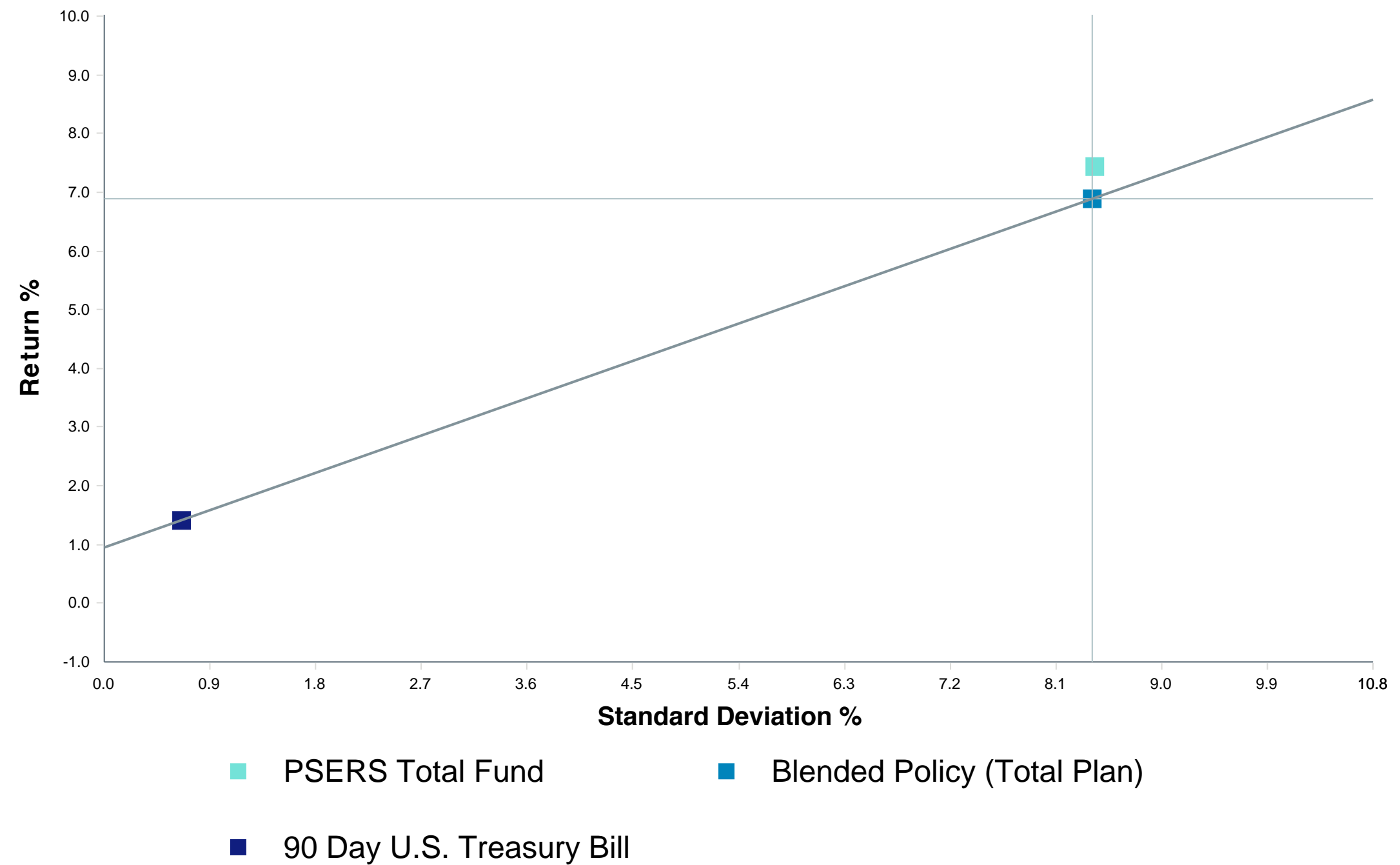




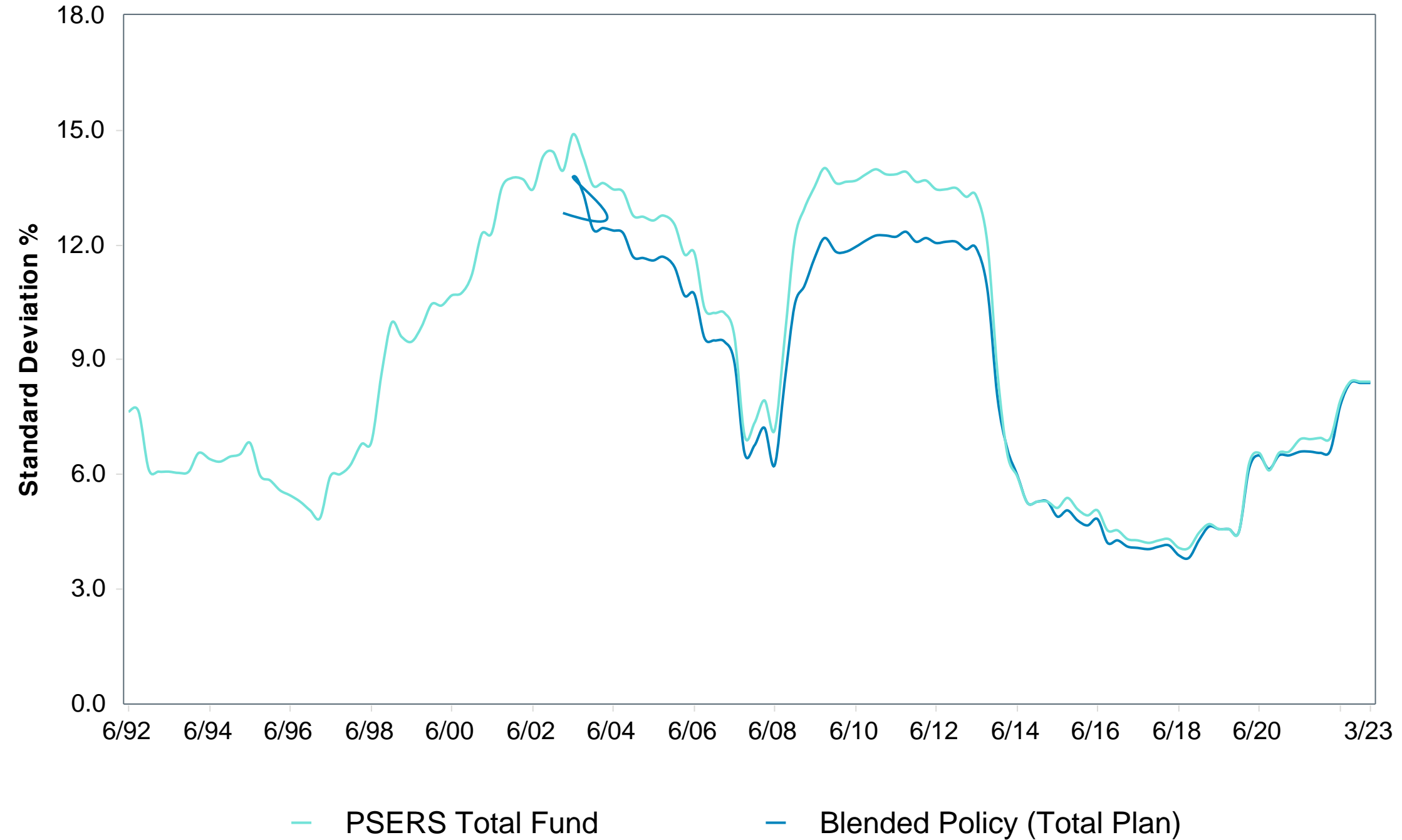

Annualized Return vs. Annualized Standard Deviation 5 Years



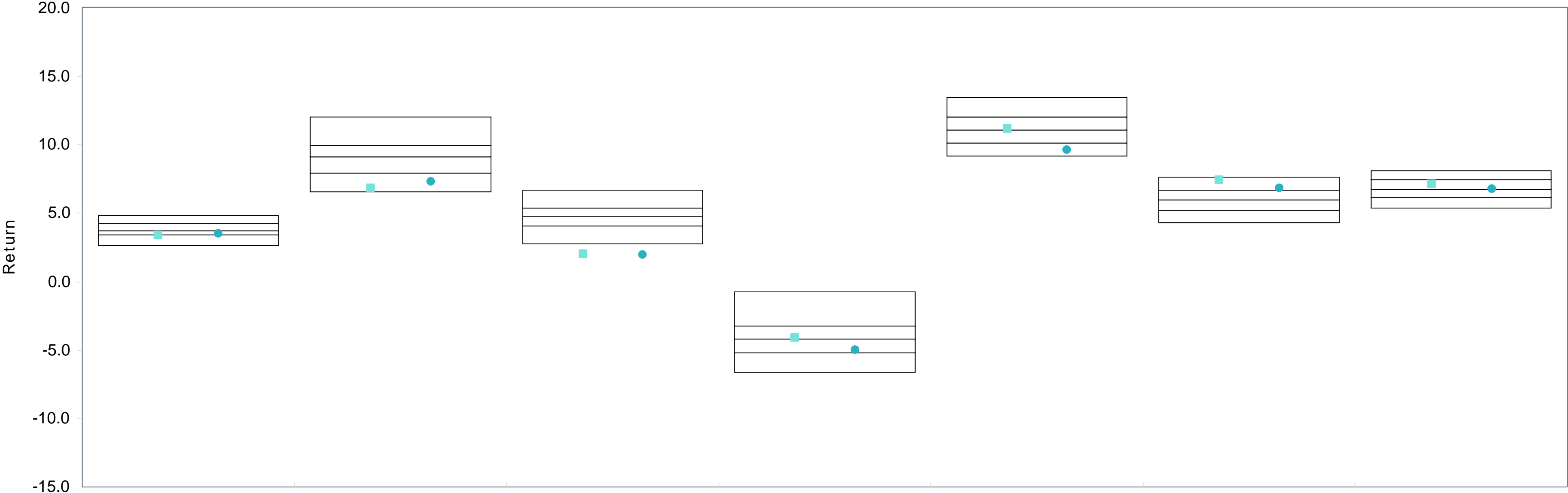

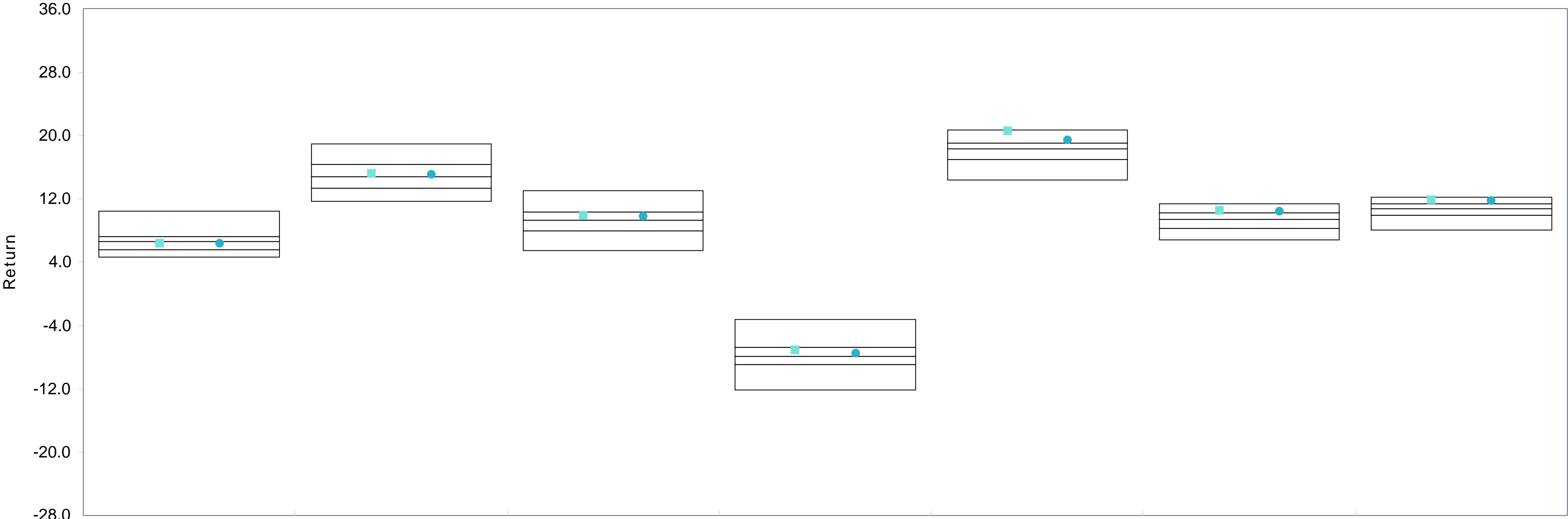

Total U.S. Equity - All Public Plans > \$1B-US Equity Segment - As of March 31, 2023



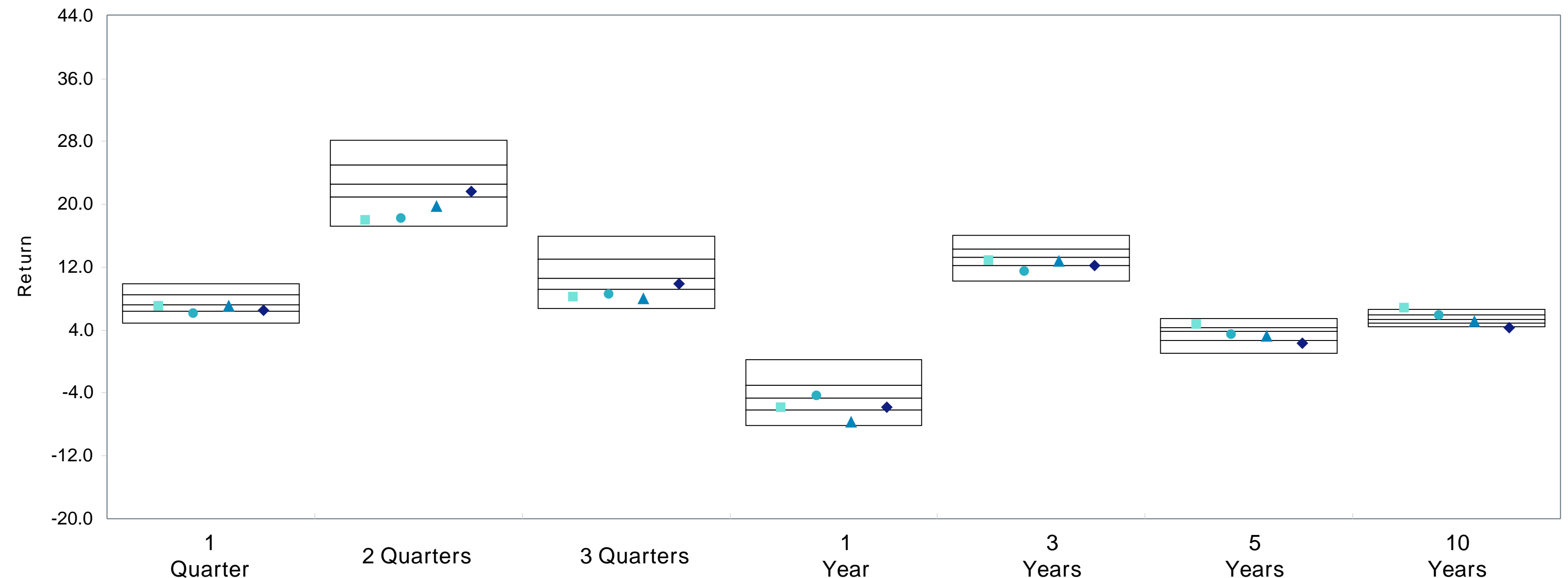

Total Non-U.S. Equity - All Public Plans > \$1B-Intl. Equity Segment - As of March 31, 2023



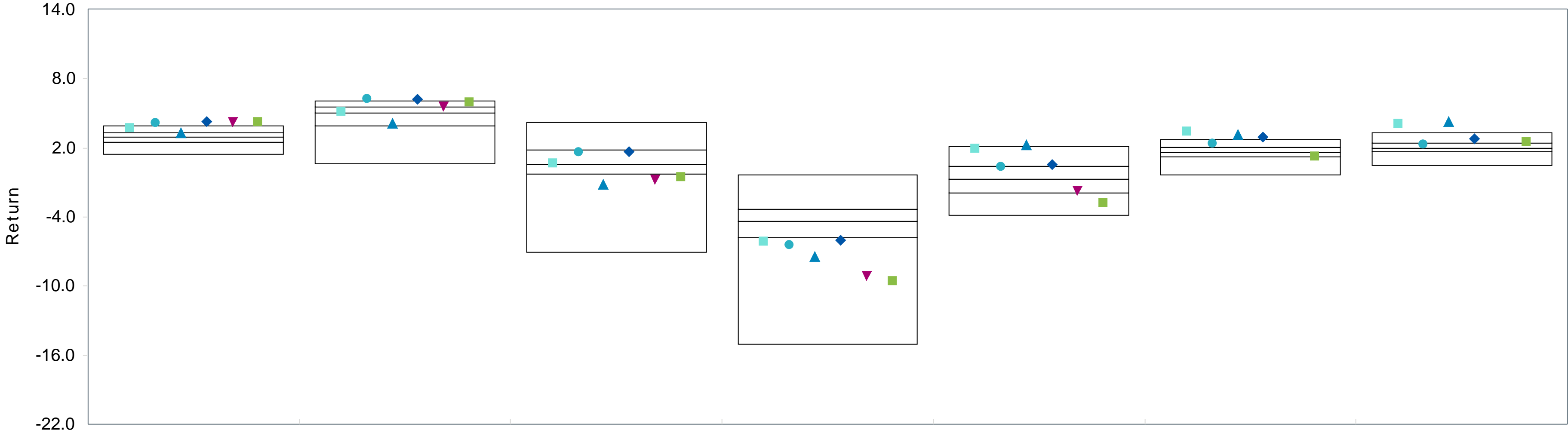

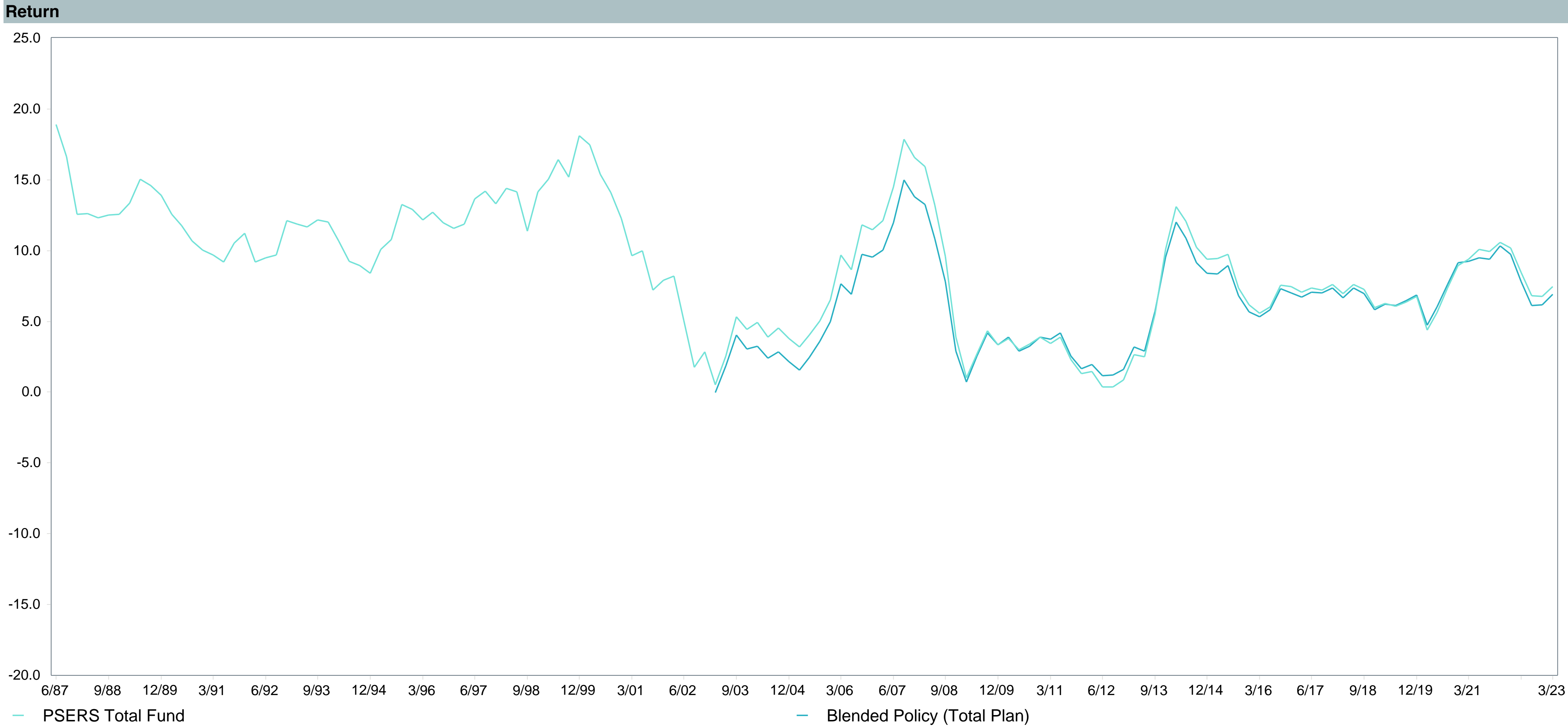
# 3-Year Rolling Returns

PSERS Total Fund - 20 Quarters Rolling Periods As of March 31, 2023



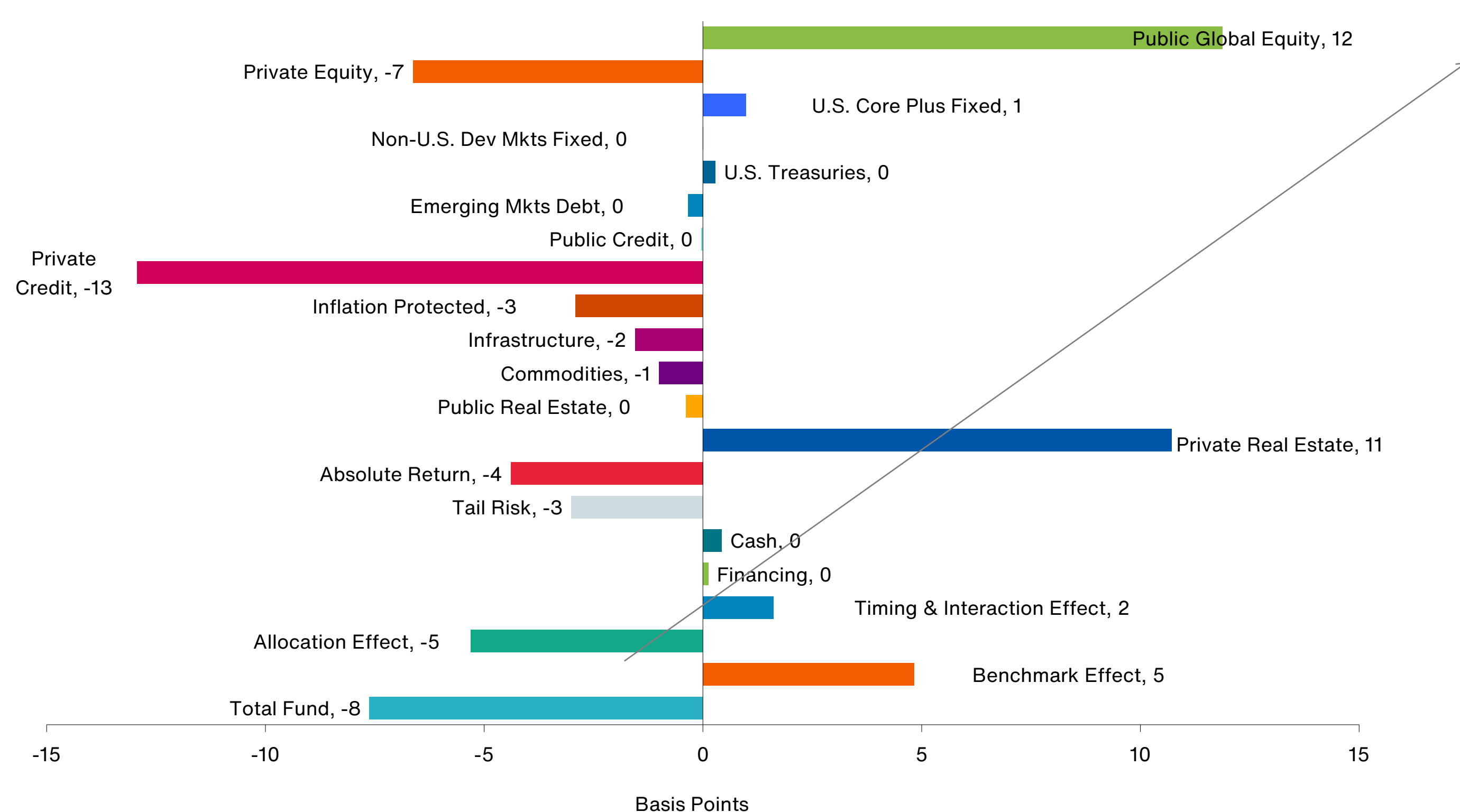

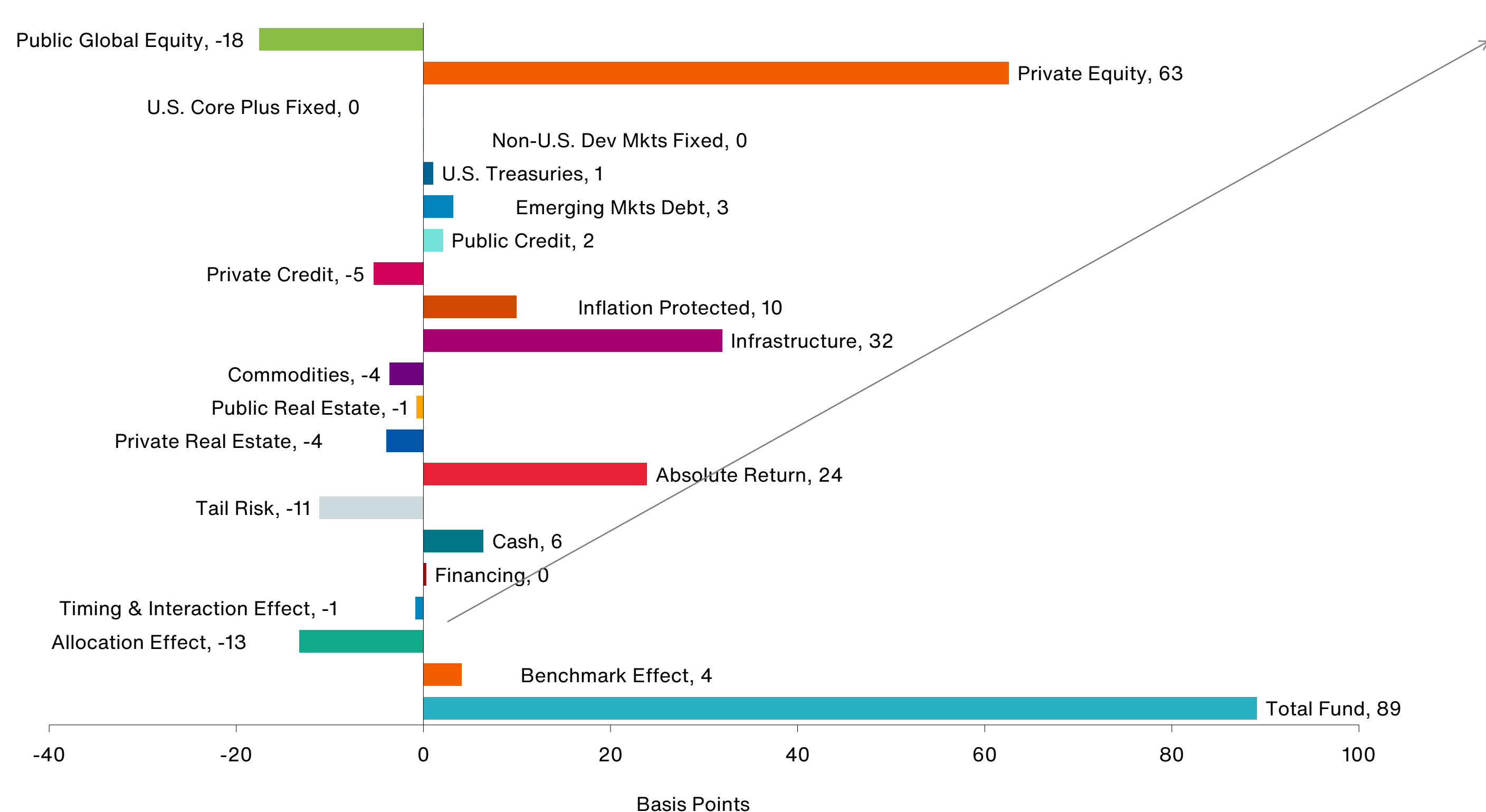
