Payment Due Dates:

Pink = Member Share payment due on the 10th of the month or two business days prior to the 10th for the previous month

Light Green = Employer Share payment due

- 4th** Quarter of 2021 due = 03/22/2022 (Tuesday)
- 1st** Quarter of 2022 due = 06/22/2022 (Wednesday)
- 2nd** Quarter of 2022 due = 09/22/2022 (Thursday)
- 3rd** Quarter of 2022 due = 12/22/2022 (Thursday)

Employer Share Rate:

- FY 21/22 = 34.94%
- FY 22/23 = 35.26%

Payment Notes: (if applicable)

- Employer Share Payments are due five (5) business days after the subsidy payment from PDE.
- If the work report is submitted after the 20th of the month for the prior month's activity the PDE subsidy payment for the late work report month(s) may be delayed to a future quarter.
- If a payment is not received timely, we will have PDE send the quarterly subsidy payment(s) directly to PSERS to cover all or a portion of the amount owed/past due.

Other Important Dates:

- NQPT Refunds (for FY 20/21) will be processed in February 2022.
- FY 21/22 reporting must be finished by September 20, 2022.
- Mailing of FY 21/22 Member Statements of Account by December 31, 2022.
- Decision on the Employer Rate for FY 23/24 at Board Meeting on December 3-4, 2022
- Any system maintenance will be announced on the PSERS website.

Reminders:

- Wages earned from July 1, 2021 to June 30, 2022, should be reported as FY 2022
- Wages earned from July 1, 2022 to June 30, 2023, should be reported as FY 2023
- Effective 7/1/2019 new employees in the system should be enrolled as Class TG.
- Please check the membership class for new employees. Employees may have elected into Classes TH or DC prior to working for you.
