**RED =** PSERS Closed

1st of each month = Monthly Statement available

**OLIVE GREEN =** CROQ Report available every Monday

**BLUE =** Monthly Report due on the 20<sup>th</sup> of the month or last business day prior to the 20<sup>th</sup> for the previous month

### Payment Due Dates

**PINK =** Member Share Payment due on the 10<sup>th</sup> of the month or two business days prior to the 10<sup>th</sup> for the previous month

**LIGHT GREEN =** Employer Share Payment due

Employer Share Rate: FY 2023 = 35.26% FY2024 = 34.00%

- 4th Quarter of 2022 due = 03/23/2023 (Thursday)
- 1st Quarter of 2023 due = 06/23/2023 (Friday)
- 2nd Quarter of 2023 due = 09/25/2023 (Monday)
- 3rd Quarter of 2023 due = 12/26/2023 (Monday)

### Payment Notes (if applicable)

1. Employer Share payments are due 5 business days after you receive your subsidy payment from PDE
2. If your work report is submitted after the 20<sup>th</sup> of the month for the prior month's activity, your PDE subsidy payment for the late work report month(s), may be delayed to a future quarter
3. If a payment is not received timely, we will have PDE send the quarterly subsidy payment (s) directly to PSERS to cover all or a portion of the amount owed/past due

- NQPT Refunds: will be processed February 2023 (for FY 21/22)
- FY 22/23 must be finished: September 20, 2023
- Mailing FY 22/23 Member Statements of Account by December 31, 2023
- Employer Rate Decision for FY 24/25; Board Meeting on December 4-5, 2023

\*Wages earned from July 1, 2023 to June 30, 2024, should be reported as FY 2024
