- 1 Click *Member Login (MSS)*.
  - Click the blue *Click here to register or login* button, then click *Register*.
  - Read and accept the terms and conditions, then provide your PSERS ID, social security number, and date of birth.
- 2 Create a username and password to set up your MSS account, then choose and answer three security questions to complete your registration.
- 3 On your MSS home page, click the link in the *Voya Account Access* box to access your PSERS DC account.

You can also set up the app to remember you or use the face/touch ID capabilities for convenient login in the future.
