1.4 Proposed Changes to Bylaws

Rep. Matt Bradford presented proposed changes to the PSERS Committee Charters; the most substantive changes are to the Finance & Actuarial Charter to expand list of finance functions, contemplated and to remove some items that are the responsibility of the Investment Committee. Additionally other charter changes are proposed to maintain consistency, including the language to Governance & Administration Committee, Audit, Compliance & Risk Committee, and Investment Committee charters tasking them to recommend vital signs for the functions under their oversight. Also adding language to Section 3 of each charter concerning how meetings should be conducted to reference adherence to established rules of order. Finally, charters that include language tasking a committee with recommending positions on legislation will be removed.

Rep. Matt Bradford moved that the Governance & Administration Committee adopt all the recommended changes to the various Committee charters and send them to the full Board for consideration and approval. Melva Vogler seconded the motion, which <u>passed unanimously</u>.

The recommend changes will move to full Board for consideration, and in accordance with the Bylaws, they require 15-day notice before the Board considers. Chairperson Santa Maria will decide if a special meeting of the Board is required before the October meeting.

Rep. Matt Bradford moved to recommend to the full Board recommendations made by Board Vice-Chairperson Rep. Frank Ryan for Bylaw change that would amend the language on succession in the event any committee Chair is unable to serve the entire elected term from holding an election, to see the Vice-Chair assume the Chairmanship for the remainder of the term. Sec. Richard Vague seconded the motion, which <u>passed unanimously</u>.

1.5 Review of Strategic Planning Policy

Rep. Matt Bradford presented the Strategic Planning Policy to establish the guidelines for a strategic planning process as recommend by Funston. The draft had previously been circulated to Board members and had been updated to reflect input from Board members.

Rep. Matt Bradford moved to recommend the Strategic Planning Policy to the full Board. Melva Vogler seconded the motion, which <u>passed unanimously</u>.

1.6 Review of Travel Policy Amendment

Sec. Richard Vague discussed an amendment to the Board Travel Policy to clarify language regarding third-party travel reimbursement provisions for contracts executed prior to the original policy adoption. He then made a recommendation to the full Board for approval. Melva Vogler seconded the motion, which <u>passed unanimously</u>.
