



Asset Allocation as of September 30, 2022 (Unaudited)






PSERS' Investment Portfolio Asset Allocation as of September 30, 2022 (Unaudited)






PSERS' Historical Asset Allocation


PSERS' Historical Net Investment Portfolio






PSERS' Gross Investment Portfolio


