Payment Due Dates

Pink = Member Share payment due on the 10th of the month or two business days prior to the 10th for the previous month

Light Green = Employer Share payment due

Employer Share Rate:

FY 19/20 = 34.29%; FY 20/21 = 34.51%

- 4th Quarter of 2018 due = 3/23/2020 (Monday)
- 1st Quarter of 2020 due = 6/23/2020 (Tuesday)
- 2nd Quarter of 2020 due = 9/23/2020 (Wednesday)
- 3rd Quarter of 2020 due = 12/23/2020 (Wednesday)

Payment Notes (if applicable)

1. Employer Share payments are due 5 business days after you receive your subsidy payment from PDE
2. If your work report is submitted after the 20th of the month for the prior month's activity, your PDE subsidy payment for the late work report month(s), may be delayed to a future quarter
3. If a payment is not received timely, we will have PDE send the quarterly subsidy payment(s) directly to PSERS to cover all or a portion of the amount owed/past due

- NQPT (for FY 18/19) Refunds will be processed in February 2020
- FY 19/20 must be finished by September 20, 2020
- Mailing of FY 19/20 Member Statements of Account by December 31, 2020
- Decision on the Employer Rate for FY 21/22 at Board Meeting on December 3-4, 2020
- Any system maintenance will be announced on the employer web

*Wages earned from July 1, 2020 to June 30, 2021, should be reported as FY 2021
