
James Sando Reelected to Board Seat


Since 1987, Mr. Sando has been a fifth grade teacher at the Wissahickon School District. He received his Masters of Education from East Stroudsburg University.

From the Desk of the Exective Director

A Message from PSERS Executive Director, Mr. Jeffrey B. Clay...

Update on the Pension Funding Issue and the Employer Contribution Rate Recertification

In my last column I discussed the extensive educational efforts PSERS has undertaken over the past year to explain the employer contribution rate spike and the funding issues facing PSERS to various employer and member organizations and to the Legislature.

Traveling across the Commonwealth and giving over 60 presentations over the last year and a half to various school boards, school business officials, active and retired member groups, and legislators gave me the opportunity to hear firsthand the concerns and comments of PSERS members and employers.

As legislators and school officials achieved a better understanding of the funding issue, the focus has now turned towards finding a solution to this issue. Thus, a number of pieces of legislation have been introduced to address the funding issue. More legislation or amendments to pending bills can be expected as we get closer to the employer contribution rate spike in Fiscal Year 2012/2013. Examples of some of the bills already introduced in the current Legislative session include:

Senate Bill 566 – Introduced by Senator Patrick Browne, *and...*

House Bill 1174 – Introduced by Representative Scott Boyd

These are identical bills that have been introduced in both chambers of the General Assembly. The bills propose the establishment of a Defined Contribution Plan for all new members enrolling in PSERS.

Senate Bill 1185 – Introduced by Senator Yaw, and...

House Bill 2135 – Introduced by Representative Glen Grell

These are identical bills that have been introduced in both chambers of the General Assembly. The bills propose the establishment of a Hybrid Pension Plan for all new members enrolling in PSERS. The Hybrid Plan would have components of both a Defined Benefit Plan and Defined Contribution Plan.

House Bill 2497 – Introduced by Representative Dwight Evans

This bill proposes a series of actuarial changes to PSERS and SERS and includes eligibility and benefit changes for new PSERS and SERS members hired after the effective date of the legislation.

Of all pension funding legislation that has been introduced, House Bill 2497 is the only piece of legislation addressing the funding issue that has passed one chamber of the General Assembly, that being the House of Representatives. Passed on June 16, 2010, the bill was sent to the Senate, where it was referred to the Senate Finance Committee. As of the date this article was written, the bill still resides in this Senate committee without having been acted upon.

This fall when the Legislature returns to session, PSERS will continue to closely monitor pension legislation and provide analytical and technical support for new bills and/or amendments to the existing bills.

If no legislation to resolve the pension funding issue passes this fall, PSERS will continue its educational efforts on this important issue, particularly in light of the expected changes to take place in the Office of the Governor and the General Assembly due to the November elections.

The pension funding issue also remains a top issue for the PSERS Board of Trustees (PSERB). As a consequence of passage of the Fiscal Code Bill (Act 2010-46) that accompanied the Commonwealth's General Fund Budget

(Act 2010-1A), the PSERB met in July 2010 and recertified the employer contribution rate for Fiscal Year 2010-2011. The rate was decreased from 8.22 percent down to 5.64 percent as directed under the provisions of Act 46.

Unlike past recertifications of the employer contribution rate by the PSERB. this recertification was not the result of either a modification of PSERS' funding methodology or any other change made to the Public School Employees' Retirement Code. Therefore, the PSERB passed a resolution that voiced its concern and stated that the mandated recertification of the employer contribution rate not only fails to address the serious long-term under-funding of PSERS, but increases the unfunded liability of PSERS.

Eligibility & Waiving Membership

Participation with PSERS is a requirement for all full-time employees. This means that these employees must have contributions withheld beginning with the first day of public school service. Full-time employment is described as employees who work 5 or more hours a day, 5 days a week or its equivalent of 25 or more hours a week.

Part-time employees must work a minimum of 500 hours (if hired on an hourly basis) or 80 days (if hired on a per diem basis) in a school year (July 1 through June 30) to qualify for membership. When a part-time employee meets the minimum membership requirement, employers must begin to withhold PSERS contributions. Employers do have the option to begin withholding contributions for part-time employees from the first day of employment if the employer believes that the employee will work the necessary time to meet the minimum membership requirements.

Employers must offer the option of waiving membership in PSERS to all part-time salaried, part-time hourly, and part-time per diem employees. PSERS recommends that this process occur within the first 30 days of the employee being hired in order to avoid the unnecessary withholding of retirement contributions. The employee has until the end of the school year in which he or she wishes to waive membership to exercise this option, but waiting can result in deductions being withheld unnecessarily and delays in the return of contributions.

To qualify for the waiver, a part-time employee must maintain one of the following types of Individual Retirement Accounts (IRA) as defined by Section 408 in the Internal Revenue Code:

- Traditional IRA
- Roth IRA
- Simplified Employee Pension (SEP)
- Savings Incentive Match Plan for Employees of Small Employers (Simple) IRA

It is up to the employee to contact the employer should the employee decide to waive membership in PSERS. The employer will request IRA verification from the employee and report the waiver request to PSERS. Once the request is received by PSERS, we mail a Welcome Waiver Packet to the employee. Part of this packet includes a PSERS Membership Waiver (PSRS-51) form. The employee must complete and return this form to PSERS by the end of the current school year in order to qualify for the membership waiver.

Submission of the completed waiver is binding for the entire school year

in which membership is being waived unless the employee becomes a full-time school employee.

If a waiver request is denied or if the employee does not return the waiver form prior to the end of the current school year, PSERS will contact the employee to explain the reason for the denial.

It is important to note that once part-time membership is waived and the employee later becomes a member of PSERS, the waived service becomes ineligible for purchase as PSERS credited service.

Planning for Retirement

If you are planning to retire at the end of this school year, by now you should have:

- Applied to purchase any uncredited service (POS), if applicable.
- Attended a PSERS Foundations For Your Future program.
- Received a PSERS Retirement Estimate.
- Contacted your employer to discuss benefits available through them such as payment for unused vacation, sick leave, sabbatical leave, and health insurance.
- Consulted with a financial planner or a tax consultant, if appropriate.
- Contacted the Social Security Administration regarding your benefits.

By November, you should have:

- Investigated your employer's guidelines for retiring, terminating, and resigning.
- Scheduled a PSERS Exit
 Counseling session through
 your PSERS Regional Office.

Between January and prior to your termination, you should:

- Attend a scheduled PSERS
 Exit Counseling session.
- Notify your public school employer(s) of your termination and date.
